Amending The Constitution. The Facts. 1. According to Article V, amendments can be proposed by a two-thirds majority vote in Congress or at a constitutional convention called by two-thirds of the states. In order for a proposed amendment to become part of the Constitution, approval by three-quarters of the states is required.
